<u>Note</u>: In Mexico the title "Licenciado" (abbreviated Lic.) is used to indicate a professional person, not necessarily an attorney. All "Licenciados" on the list are attorneys licensed to practice law. The terms "Bufete" and "Despacho" refer to a law office or law firm.
