Failure to be registered at time of proposal submission may deem the offeror's proposal to be considered non-responsible and no further consideration will be given. Therefore, offerors are highly encouraged to register immediately if they are interested in submitting a response to this requirement.

The U.S. Government intends to award a contract to the responsible company submitting an acceptable quotation at the lowest price. We intend to award a contract based on initial quotations, without holding discussions, although we may hold discussions with companies in the competitive range if there is a need to do so.

I. SCOPE OF SERVICES

The Contractor shall perform moving services in Lima, Peru for household furniture, appliances and other assets owned by the U.S. Government for twelve (12) consecutive months in accordance with attached Statement of Work.

During the term of the service agreement, the contractor shall perform, without limitation services to and from the U.S. Embassy's warehouse (Av. Lima Polo Cdra. 2, Monterrico, Surco), FAP Warehouse (ALDEA2 Coop. Las Vertientes Calle 6 Mz J Lote 2 Villa el Salvador), Official Residences (CMR, DCMR and MSGR) and various Embassy leased residences mainly located in the Lima area.

This is an indefinite-delivery, indefinite-quantity, type contract. Individual purchases shall be documented by firm fixed-price Task Orders within the rates designated.

The quantities of services specified in the Schedule are estimates only and are not guaranteed by this contract.

II. PERIOD OF PERFORMANCE

A) The performance period of this contract is for a one-year period from the date of the contract award, with three (3) one-year options.

B) The Government may extend this contract for up to three (03) additional 12-month periods, in accordance with the option clause in Section II. 52.217 -9, Option to Extend the Term of the Contract. which also specifies the total

duration of this contract. See also Section II, FAR 52.21 7-8, Option to Extend Services, for up to an additional six months of optional performance, if required by the Government.

III. MINIMUM AND MAXIMUM AMOUNTS

During this contract period, the Government shall place orders totaling a minimum of USD 500.00. This reflects the contract minimum for each period performance. The amount of all orders shall not exceed USD 120,000.00. This reflects the contract maximum for each period of performance.

IV. PRICING

- A) The Government will pay the Contractor a fixed price per month for Standard Services that have been satisfactorily performed.
- B) This price shall include all labor, materials, all insurance, overhead, profit and applicable taxes. Prices shall be provided in USD.

H) GOVERNMENT APPROVAL AND ACCEPTANCE OF CONTRACTOR EMPLOYEES

The Contractor shall subject its personnel to the Government's approval. All employees must pass a suitable investigation conducted by the Contractor, including recommendation(s) from their respective supervisor(s). Also required: (1) a police check covering criminal and/or subversive activities; (2) a check of personal residence, and (3) a credit investigation. The Contractor shall provide all such investigations in summary form to the COR for review and approval or disapproval. **THE CONTRACTOR SHALL NOT USE ANY EMPLOYEES UNDER THIS CONTRACT WITHOUT GOVERNMENT APPROVAL.**

I) PERSONAL INJURY, PROPERTY LOSS OR DAMAGE (LIABILITY)

The Contractor hereby assumes absolute responsibility and liability for any and all personal injuries or death and/or property damage or losses suffered due to negligence of the Contractor's personnel in the performance of the services under this contract.

J) INSURANCE

The Contractor, at its own expense, shall provide and maintain during the entire period of performance of this contract, whatever insurance is legally necessary. The Contractor shall carry during the entire period of performance the following minimum insurance:

K) BONDING OF EMPLOYEES

The Government imposes bonding requirement on this contract. The Contractor shall provide any official bonds required, pay any fees or costs involved or related to equipping of any employees engaged in providing services under this contract, if legally required by the local government local practice.

L) PERMITS

At no cost to the Government, the Contractor shall obtain all permits, licenses, and appointments required for the prosecution of work. The Contractor shall obtain these permits, licenses, and appointments in compliance with applicable host country laws. The Contractor shall provide evidence of possession or status of application for such permits, licenses, and appointments to the Contracting Officer with its proposal. Application, justification, fees, and certifications for any licenses required by the host government are entirely the responsibility of the offeror.

C.1 . STATEMENT OF WORK

C.1.1 General.

The Contractor shall perform moving services in Lima, Peru for household furniture, appliances and other assets owned by the U.S. Government.

During the term of the service agreement, the contractor shall perform, without limitation services to and from the U.S. Embassy's warehouse (Av. Lima Polo Cdra. 2, Monterrico, Surco), FAP Warehouse (ALDEA2 Coop. Las Vertientes Calle 6 Mz J Lote 2 Villa el Salvador), Official Residences (CMR, DCMR and MSGR) and various Embassy leased residences mainly located in the Lima area.

The contractor shall provide all equipment, materials, managerial, administrative, transportation and direct labor personnel necessary to accomplish the work in this contract. The contractor employees shall be on site only for contractual duties and not for other purposes. The contractor shall furnish all personnel to meet the standards established in this contract.

C.1.2. Personnel

The contractor shall provide a qualified work force meeting the contract requirements. The workforce shall be able to efficiently provide the services identified in this section. It is anticipated that the contractor will provide:

Project Manager
Truck Drivers
Laborers

The Project Manager is considered key personnel and cannot be substituted during the performance of this contract. The Project Manager shall be fluent in the English language.

The Government reserves the right to deny access to U.S-owned or U.S-operated facilities to any individual.

C.1.3 General Requirements

C.1.3.1 Definitions

"General Instructions" mean those instructions, directives and guidelines that apply to all warehouse support service personnel.

"Chancery" means the Embassy building.

"CMR" means the official residence of the ambassador.

"Daily" means 5 days per week, on each non-holiday workday.

"DCMR" means the official residence of the Deputy Chief of Mission.

"Work Order" means a task or work instructions given to the contracted laborer with a specific timeline for completion. These are issued daily and indicate the routine actions that are expected of the contractor per the contract.

"GSO" means the General Services Office.

"Embassy" means the United States Embassy.

"USG" means United States Government.

"CO" means Contracting Officer.

"PO" means Purchase Order.

C.1.3.2 The Contractor shall prepare general instructions for the work force. The Contractor shall provide drafts to the Contracting Officer's Representative (COR)

C.1.3.3 Vehicles.

The Contractor shall ensure vehicles used in this move are in proper mechanical condition to ensure their full availability during the move period and to assure that US Government property is reliably and safely transported. The Contractor shall provide all fuel and lubricants for their vehicles and equipment. Non-availability of suitable vehicles or equipment shall not constitute acceptable justification for either late performance or additional cost to the Embassy.

The Contractor shall provide a list of all vehicles to be used in the move (make, model/description, license number) as part of the updated move plan. Load cargo capacity: from 1 TN up to 4 TN and/or 30m³.

C.1.4 Duties and Responsibilities

Contractor shall coordinate and schedule services on a weekly basis with the COR.

The forty-eight-hour performance standard is intended to allow the contractor enough time to perform the work and coordinate delivery schedules with the COR in a manner that meets all programmatic and logistic requirements. For an urgent request, the CO may order services orally and with less advance notice. Such orders will be confirmed in writing the following workday.

C.2. TYPE OF SERVICES

Standard services shall include the following:

C.2.1 Schedule

The contractor agrees that he shall execute each individual order within forty-eight-hours after the receipt of a written advance notice from the Embassy. The contractor will further fully respect all work schedules established between the Contracting Officer's Representative (COR) and the contractor.

The contractor will receive a weekly update by the Contracting Officer's Representative (COR) for the moves related to the Make Ready, and contractor shall complete each service in a maximum of two days but in some cases, the services shall be completed on a single day.

Make Ready moves are performed on consecutive days but when required, it can be split in two separate days in coordination with Contracting Officer's Representative (COR).

C.2.2 Pickup

The contractor shall pickup the goods from the designated location on the PO. Upon the pickup the contractor shall verify the tag number of each asset and confirm that is listed on the documentation for transfer (DS584 and/or DS583).

Condition of the assets must be verified before loading them to the vehicle and any discrepancies must be noted on the documentation and reported to the COR immediately. The contractor shall ensure that the goods are properly placed on the vehicle not to damage USG property.

C.2.3 Moving

The contractor is fully responsible to safely transport and manipulate the USG assets between designated locations, in compliance with the local laws and regulations. The transportation is to be performed by the vehicles listed on C.1.3.3. No changes should be made without the prior notification and approval by the Contracting Officer's Representative (COR).

The contractor shall move the furniture by hand or elevator to complete the service on the designated location and date.

C.2.4 Set up

The contractor shall review the residence and furniture/appliances condition before moving in or out items and report any inconsistencies to the Contracting Officer's Representative (COR). The contractor shall use proper equipment to prevent damages to existing furniture or infrastructure at the designated location.

The contractor must use the "Furniture Survey" and Transfer documents (DS584 and/or DS583) provided by the Property Team to properly set up the residence. The contractor shall build and/or fix a minor issue on any furniture if needed.

C.2.5 Cleaning

The contractor shall clean all soft and hard furniture that will remain at the residence. There should be no odor and/or stains left on the furniture. The contractor shall perform this service on the same days designated for the move.

C.3. MANAGEMENT AND SUPERVISION

C.3.1. Management: The contractor shall designate a Project manager who shall be responsible for handling all business with the Embassy.

C.3.2. Supervision: The project manager shall always be responsible for the on-site supervision of the contractor's work force to ensure that the services are being delivered under this contract. The project manager will be the contractor's primary point of contact and will act as liaison with the US Embassy personnel. He shall have sufficient English language skills to be able to communicate easily and efficiently with members of the US Embassy staff.

C.3.3. Quality Control: Shall be the responsibility of the contractor. The contractor shall perform inspection visits to the work site on a regular basis. Inspection visits shall be surprise inspections for those working on the contract. The inspections should have a minimum of 3 per month.

C.3.4. Safety: The Contractor shall be responsible for work site safety during the moves.

C.3.5. Professional Bearing and Courtesy: All contractor employees shall:

- Be courteous at all times;
- Arrive at the work site promptly at the scheduled time with materials necessary to properly complete the job;
- Present credentials identifying themselves as employees of the company;
- Refer any irresolvable questions to the COR;
- Arrive at the work site in proper and clean company uniforms.

The contractor's employees shall not at any time:

- Smoke in the client's facility or residences.
- Arrive at the facility or residences under the influence of drugs or alcohol, or even with alcohol on the breath.
- Drink alcoholic beverages on the job, even if offered.
- Use the client's bathroom or towels without permission.
- Engage in prolonged discussions or arguments regarding the job.
- Perform any work for the client not specified in this contract; or
- Request or accept any articles or currency as a gratuity from the client for work performed under this contract.
- Sleep on the residences at any given time.

C.4. OPERATIONAL RECORDS

The contractor shall provide and maintain LOGS, listing the names of the driver(s) and the movers, the time of departure from the Embassy warehouse or pick-up

address, the time of completion of each individual move, and the time of return to the Embassy warehouse.

C.5. SECURITY CLEARANCE

If requested by the Contracting Officer, the contractor shall provide the names, biographic data and police clearances for all contractor personnel used on this contract prior to their utilization. Upon approval of their utilization, the Government may issue identity cards to contractor personnel, each of whom shall display his/her card(s) on his/her uniform at all times while on Government property or while on duty at private residences. The identity cards are the property of the U.S. Government, and the contractor is responsible for their return upon expiration of the contract, when an employee leaves the contractor's service, or at the request of the U.S. Government.

Depending upon the outcome of the background investigation, the U.S. Government reserves the right to deny access to US-owned, leased, or operated facilities to any individual.

C.6. CONTRACTOR FURNISHED MATERIALS

The contractor shall provide all equipment, materials, supplies, transportation, and clothing required to perform the services as specified in this contract. Such items include, but are not limited to, vehicles; uniform, routine office supplies; and any equipment or administrative items required for performance under this contract. The contractor shall maintain sufficient parts and spares for all contractor furnished equipment and materials to ensure uninterrupted provision of services as required by the contract.

C.7. GOVERNMENT FURNISHED PROPERTY

The Government does not intend to make any equipment or materials available to the Contractor as "Government furnished property (GFP)" for performance of the contract.

QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.

3. PROCEDURES.

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

(3) Furnishing information with respect to the race, religion, or national origin of any U.S. person or of any owner, officer, director, or employee of such U.S. person;

(4) Furnishing information about whether any person has, has had, or proposes to have any business relationship (including a relationship by way of sale, purchase, legal or commercial representation, shipping or other transport, insurance, investment, or supply) with or in the State of Israel, with any business concern organized under the laws of the State of Israel, with any Israeli national or resident, or with any person which is known or believed to be restricted from having any business relationship with or in Israel;

(5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,

(6) Paying, honoring, confirming, or otherwise implementing a letter of credit which contains any condition or requirement against doing business with the State of Israel.

- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

(11) (Complete if the offeror has represented itself as disadvantaged in paragraph (c)(4) of this provision.)

_____ Subcontinent Asian (Asian-Indian) American (persons with origins from India, Pakistan, Bangladesh, Sri Lanka, Bhutan, the Maldives Islands, or Nepal).

_____ Individual/concern, other than one of the preceding.

52.229-11 TAX ON CERTAIN FOREIGN PROCUREMENTS – NOTICE AND REPRESENTATION (JUN 2020)

(a) *Definitions.* As used in this provision—

Foreign person means any person other than a United States person.

Specified Federal procurement payment means any payment made pursuant to a contract with a foreign contracting party that is for goods, manufactured or produced, or services provided in a foreign country that is not a party to an

international procurement agreement with the United States. For purposes of the prior sentence, a foreign country does not include an outlying area.

United States person as defined in 26 U.S.C. 7701(a)(30) means—

- (1) A citizen or resident of the United States;
- (2) A domestic partnership;
- (3) A domestic corporation;
- (4) Any estate (other than a foreign estate, within the meaning of 26 U.S.C. 701(a)(31)); and
- (5) Any trust if—
 - (i) A court within the United States is able to exercise primary supervision over the administration of the trust; and
 - (ii) One or more United States persons have the authority to control all substantial decisions of the trust.
- (b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.
- (c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). The Offeror would claim an exemption from the withholding by using the Department of the Treasury Internal Revenue Service Form W-14, Certificate of Foreign Contracting Party Receiving Federal Procurement Payments, available via the internet at www.irs.gov/w14. Any exemption claimed and self-certified on the IRS Form W-14 is subject to audit by the IRS. Any disputes regarding the imposition and collection of the 26 U.S.C. 5000C tax are adjudicated by the IRS as the 26 U.S.C. 5000C tax is a tax matter, not a contract issue. The IRS Form W-14 is provided to the acquiring agency rather than to the IRS.
- (d) For purposes of withholding under 26 U.S.C. 5000C, the Offeror represents that—
 - (1) It is is not a foreign person; and

(2) If the Offeror indicates “is” in paragraph (d)(1) of this provision, then the Offeror represents that—I am claiming on the IRS Form W-14 [____] a full exemption, or [____] partial or no exemption [*Offeror shall select one*] from the excise tax.

(e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations. A revenue ruling is the conclusion of the IRS on how the law is applied to a specific set of facts. 652.225-70 ARAB LEAGUE BOYCOTT OF ISRAEL (AUG 1999)

(a) Definitions. As used in this provision:

Foreign person means any person other than a United States person as defined below.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

(b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion.
