

# LIST OF ATTORNEYS IN THE BAHAMAS

The Commonwealth of The Bahamas consists of approximately 700 islands, stretching from the coast of Florida almost to the shores of Haiti. Only about 20 of the islands are inhabited, with the majority of the population concentrated on the islands of New Providence (Nassau) and Grand Bahama (Freeport). The Turks and Caicos Islands, though a part of the same archipelago, form a British Dependent Territory and are therefore politically separate from the Bahamas. The Embassy maintains a separate list of Lawyers who practice in the Turks & Caicos Islands.

The Government of the Commonwealth of The Bahamas has enacted Value Added Tax (VAT) legislation with a rate of 10% which will apply to certain services, fees, and disbursements.
